Unique Authentication Code



A unique 16-digit code is assigned to every Record our system generates. We permanently archive the original file so that any electronically certified TalkingParents record can be authenticated as genuine and accurate if necessary. The Unique Authentication Code is located at the bottom of every page of the record.

From our Servers to the Courtroom



When a TalkingParents parent requests a copy of their Record through our app or website, our system then compiles the requested information from our secure servers. The parent can then download the PDF file and they also have the option of ordering a printed copy of the file from us, which we then ship to the address of their choosing. When a parent requests a printed copy, we print the exact same file they were able to download in PDF format as if they printed it themselves. A parent can request a signed Affidavit to accompany a printed copy, but our goal is to provide sufficient Identification and Authentication through electronic means, regardless of whether the record is offered in electronic (PDF) or printed format.

Consent to Call Recording

All parents must consent to the following message before they can activate our Accountable Calling feature:

By agreeing to use our phone and video calling features, you consent to the audio and video recording of all calls made through our system. A copy of each recording will be saved and available to both parents at all times. Each time you initiate or accept a phone or video call through our system you confirm this consent.

You can withdraw your consent at any time by deactivating the phone and video calling feature.

This process is completely separate from the initial agreement to our Terms when a parent creates an account, and each parent must affirmatively click or tap "I Agree" before they can place or receive calls through our service.

Further, at the beginning of each call, an automated voice states that the call is being recorded and in order to continue each individual party must consent to recording. This statement can be heard at the beginning of the recording itself.
