

#### From our Servers to the Courtroom



When a TalkingParents parent requests a copy of their Record through our app or website, our system then compiles the requested information from our secure servers. The parent can then download the PDF file and they also have the option of ordering a printed copy of the file from us, which we then ship to the address of their choosing. When a parent requests a printed copy, we print the exact same file they were able to download in PDF format as if they printed it themselves. A parent can request a signed Affidavit to accompany a printed copy, but our goal is to provide sufficient Identification and Authentication through electronic means, regardless of whether the record is offered in electronic (PDF) or printed format.

# Info Library Notifications

Our service sends an automatic email notice every time a parent has a new or edited card to view at TalkingParents. These notices are sent as a courtesy and we cannot verify if they are actually received or viewed. Parents can turn the email notices off (or back on) at any time. Our iPhone and Android apps include built-in card notifications.



## Info Library Cards

When a parent creates a new Info Library card, they choose whether to make the card private or shared. Private cards are only visible to the parent who created them. Shared cards are visible to both parents.

Each Card contains a title (which can be edited later), the date and time it was created, and whether it was created as private or shared. Cards can contain any other information the parent wishes to include.

Cards can only be edited or deleted by the parent who created them. All edited cards are shown indented below the initial card. Edited cards include the date and time of the edit. Changes in the private/shared status of a card are shown as edits.

All card edits or deletions are logged on a separate line under the card.

Each time a parent first views a new or edited card shared by the other parent, that view is logged below the card.

Cards are presented in chronological order based on when they were created. All edits, views, and deletions are shown under the card.
